## Project Description, Justification and Location

Project will provide for the installation of a methane gas collection system at the Croft Landfill. Equipment proposed to be installed would be similar in nature to that located at the Wellford Landfill. Gas extraction wells, piping, meters, flare, and related components would be installed to collect and destroy the methane gas. Installation of a system is necessary to prevent migration of methane gas off the closed landfill site. According to SCDHEC regulations, migration of methane gas off of a landfill site is prohibited. The project will ensure continued compliance with SCDHEC regulations.



## Benefits to Residents, Visitors, Businesses, or County Employees

County residents and visitors will benefit from the collection and destruction of methane gas which is considered a greenhouse gas. If gas collection volumes are substantial, the ability to track and cell carbon credits associated with the destruction of the gas may be possible, increasing revenue for the County.
